## **2018 TENNESSEE STATE USBC MIXED TOURNAMENT RULES:**

- 1) USBC rules and those listed below will govern this tournament.
- 2) The TSUSBCMT will consist of Two Events – Team Event – Mixed Doubles
- 3) All USBC members bowling within the membership area of the State of Tennessee are eligible to enter. The members “USBC I.D Number” must be on the entry form to verify eligibility.

**Bowlers are to check in ready to bowl at least 30 minutes prior to their scheduled time.**

- 4) **Teams shall consist of four (4) bowlers – two women and two men. Mixed Doubles will be a woman and a man.**
- 5) Averages used for handicap purposes shall be the highest season average of 21 games or more in any one sanctioned league as follows: Bowlers to use (1) 2016-17 Season average,(2) if no average, use 2017-18 Season average as of **March 1, 2018**, (3) if no average, use their 2017 Summer average, (4) all others bowl scratch.

**Bowlers with a current season (2017-18) average of 10 pins higher than any previous average, 21 games or more, in any one sanctioned league, must use their average as of March 1, 2018 – Rule-319a2.**

Bowlers are responsible for verifying their own average – Rule-319a3

- 6) Individual handicaps shall be based on **90% of the difference between the bowler’s average and 220**. All awards will be based upon handicap scores.
- 7) “USBC” rules 315 (multiple participation), 319d (reporting prior prize winnings), and 319e (average adjustment for entry), and 324a (lineup changes) shall apply to all entrants.
  - a. **Bowlers may enter the Team Event and Doubles twice in each event.** Two bowlers must be changed in the Team Event to cash again. Bowlers may only cash once with the same partner.
- 8) **Closing date for all entries shall be, March 25, 2018.**

**No late entries will be accepted.**

- 9) No Team or individual shall be entitled to a refund after the Tournament Director has received the entry.
- 10) Prize moneys shall be returned 100%. Prize ratios to be distributed as follows, 1 for 8 in each event, or major fraction thereof.
- 11) Practice bowling will not be permitted on the lanes on which the entrants are scheduled to bowl within one (1) hour prior to their scheduled time.
- 12) **All returned checks will be charged \$25.00.**
